The word "producer" as used herein shall mean The Historical Miniatures Associates of New Jersey, Inc. d.b.a. NJHMA. The producer agrees to provide the above named vendor with selling space only.

Show selling space is reserved per unit on a fully paid basis. All provided tables are 96 inches by 30 inches. The subletting or sharing of tables is not permitted. Two vendor show admissions are provided per vendor contract.

Vendor agrees to pay the NJHMA the total amount by August 19, 2010 for the show selling space that the NJHMA has agreed to provide. Failure to do so voids this agreement. No refunds will be granted after August 26, 2010.

Set-up time begins at 7:00 a.m., Sunday September 19, 2010. Vendor agrees to be set-up and open for business by 10:00 a.m. and remain open until the show closes that day. Vendor agrees not to begin packing for departure prior to 4:00 p.m. Sunday September 19, 2010.

Vendor agrees not to attach anything to the Wayne PAL property and agrees to hide from view all boxes, wrappings, papers, etc. other than to display items during the show.

Vendor is responsible for the collection of all their required NJ State Sales Tax and fees and agrees to comply with all local and jurisdictional fire code requirements and pay any fine that result from their failure to comply with such regulations. Fire exits, aisles and walkways must be kept clear at all times. Merchandise and displays of any kind are not permitted in aisles or areas of egress.

The producer assumes no liability or responsibility to insure the safety or to protect in any way the property of the vendor from loss or damage caused by or resulting from fire, theft, malicious mischief, accident or any other event. Vendor is responsible for the protection of their property and must have their space attended at all times during show hours.

Vendor agrees to waive all claims against the NJHMA and its members of any and all liability for damages, injury or loss arising out of or from the use of show space or grounds or the display and or sale of items therein.

The producer reserves the right to bar from display any item(s) it deems not appropriate for display in accordance with local law or customs and reserves the right to remove vendor from the show premises if vendor offers for sale counterfeit, copied, pirated or unlicensed items or behaves in an inappropriate manner.

The producer reserves all right to interpret the intent of the provisions of this contract. The signatur on this contract will constitute agreement to comply with all provisions listed herein.
